#### **INFORMATIONAL REPORTS & STAFF COMMENTS**

Director Larson wants the commission and the public, especially the Monterey Vista Neighborhood Association, to know that we understand Pickleball at Via Paraiso Park is an important topic and we will address and resolve this issue as our resources and capacity allow. The Laguna Grande JPA will be meeting on April 21 at 6:00pm to discuss a proposal to hire a consultant to create a trail maintenance strategy and conduct an environmental review, receive a presentation from the transportation agency about the Fort Ord Regional Trail and Greenway project, and receive a presentation from the City engineering team about the North Fremont bike and pedestrian improvement project, also known as the North Fremont Gap Closure Project. Thank you to the commissioners for all the support. Director Larson commended the entire Parks and Recreation team for reinstating and reinventing services for the community.

Interim Recreation and Community Services Manager Leon said we are in the process of hiring summer staff, though recruitment is slow without CSUMB, MPC and Hartnell being on campus. Offering several programs this Summer: Tiny Tots Summer Camp, Play It Safe Summer Fun Program, Beach Volleyball Camp, Challenger British Soccer Camp, Basketball Camp, Flag Football Camp, Baseball/Softball Camp, Stem & Minecraft Lego Camp, and several others. We are trying to make it easy for parents to register and provide childcare for the majority of the day. Due to COVID-19, we are having to re-invent the wheel, but are planning for the current guidelines and will adjust as necessary as the guidelines change. Since programs take several months to plan, we are not able to have Camp Quien Sabe or Whispering Pines Day Camp this year but are hoping to bring them back next summer. The Bunny Hop Photo Op was a great success. We rehired a Sports Specialist on a part-time basis and have just started the adult softball league with 18 teams (6 men's teams and 12 co-ed teams).

Manager Marcuzzo stated Parks staff has been working on getting all of the parks and ballfields open. Volleyball nets are back up at Laguna Grande and Montecito and basketball nets are back at all locations. The final piece will be the re-opening of Dennis the Menace next Tuesday. Fuel reduction will be starting early due to the lack of rain.

#### **COMMISSIONER COMMENTS**

Commissioner Crampton is impressed with the work being done with very little notice. Commended Manager Marcuzzo and staff for the condition of the parks.

Commissioner Panetta commended the staff and thanked Manager Marcuzzo for the cherry trees at Shoreline Park and said it's nice to see people playing basketball at the courts again.

Commissioner McEwen stated how nice it is to see the cherry trees blossoming, especially after this past year. Commended Director Larson for stepping into this role; it's been a trial by fire and it is such a pleasure working with everyone. Appreciates the upbeat tone these meetings always have.

Commissioner McCarthy said there are a lot of moving parts to the Pickleball issue at Via Paraiso, but it will be resolved at some point. He looks forward to having this topic on the agenda and seeing what can be worked out and what the alternatives are. Looks forward to being able to have the commission meetings in person soon.

Commissioner Spangler shared that her children are thrilled that parks are open again. Thank you to staff for making that possible.

Commissioner Gibson reiterated Commissioner McCarthy's point in that the Pickleball concerns have been heard and looks forward to getting this item on the agenda soon. Suggested the other commissioners do some reading on what other communities have faced with Pickleball. Hopes to do a park tour this summer and looks forward to meeting in person again.

#### RECOMMENDATION:

That the Parks and Recreation Commission (PRC) receive a report on Pickleball and Tennis at Via Paraiso Park.

#### **POLICY IMPLICATIONS:**

The Parks and Recreation Commission oversees recreation activities in parks and recreational structures within the City of Monterey.

In the 2016 Parks and Recreation Master Plan (PRMP), adopted by the City Council and Parks and Recreation Commission, Section 05. Guidelines & Projects, Other Program Spaces, Pickleball states:

"A large contingent of community members have advocated for the development of pickleball courts in the City. While not typically identified as a "need" the addition of a pickleball court (or more) would meet demand in the community and add additional variety to the City's offerings. The sport is easy to play for all ages. Existing tennis courts could be repurposed for this activity. A two pickleball court (34' x 64' in total) can fit on one standard tennis court. An alternative is to build a new set of courts".

#### **FISCAL IMPLICATIONS:**

None from receiving this report.

As stated in the PRMP Goal 3. Economic and Environmental Sustainability, G3.1 Maintain and Enhance Existing Parks and Facilities, 3.1.3 "If it is necessary to develop new parks or recreation facilities, adequate maintenance and operations funds must be identified and incorporated into the project planning."

#### **ENVIRONMENTAL DETERMINATION:**

The City of Monterey determined that the proposed action is not a project as defined by the California Environmental Quality Act (CEQA)(CCR, Title 14, Chapter 3 ("CEQA Guidelines), Article 20, Section 15378). In addition, CEQA Guidelines Section 15061 includes the general rule that CEQA applies only to activities which have the potential for causing a significant effect on the environment. Where it can be seen with certainty that there is no possibility that the activity in question may have a significant effect on the environment, the activity is not subject to CEQA. Because the proposed action and this matter have no potential to cause any effect on the environment, or because it falls within a category of activities excluded as projects pursuant to

CEQA Guidelines section 15378, this matter is not a project. Because the matter does not cause a direct or any reasonably foreseeable indirect physical change on or in the environment, this matter is not a project. Any subsequent discretionary projects resulting from this action will be assessed for CEQA applicability.

#### DISCUSSION:

#### Background

As a result of community and neighborhood meetings, and funding from the Neighborhood and Community Improvement Program (NCIP) in 2017, blended pickleball lines were installed on both courts at Via Paraiso Park. Since then, pickleball activity has been enjoyed by neighbors and the public at the location. From April 2017 to August 2021, refinements have been made to both pickleball and tennis priority play times in order to balance the needs and desires of pickleball players, tennis players, and the neighborhood. Staff has also worked with pickleball players to promote appropriate parking locations and quiet play. In early 2021, the Monterey Vista Neighborhood expressed concern to the Monterey Bay Pickleball Club and City of Monterey regarding pickleball play at Via Paraiso Park. This report provides an update on the current status of pickleball for the Parks and Recreation Commission (PRC).

#### **Community Support for Pickleball**

On April 26, 2017 the PRC held a Study Session on Pickleball in Monterey where community input was received, and the Commission provided guidance on developing a short-term and a long-term strategy for accommodating pickleball in Monterey's parks, addressed proposed Neighborhood and Community Improvement Program (NCIP) projects involving pickleball courts and tennis courts, and expressed consensus on the need for pickleball players and tennis players to share public resources.

At the NCIP Committee selection meeting on April 27, 2017, no new pickleball facility projects were recommended for approval and only the Via Paraiso Park Tennis Court resurfacing project was approved for NCIP FY17 in the amount of \$1,500 which included funding for the storage unit for pickleball equipment and blended lines. Following prior Commission approval and guidance, the storage unit and the "blended" pickleball lines were installed in October 2017 on both tennis courts following its resurfacing.

#### **Priority Times: Shared Play for Tennis and Pickleball**

A key shared use issue identified and discussed at the April Study Session was that of setting "priority times" for pickleball play and tennis play at Via Paraiso Park. Following the meeting emails were received from a tennis player and the pickleball ambassador with requested times for each sport. Monday, Wednesday, and Friday mornings were requested by both the tennis player and pickleball player. Pickleball also requested Saturday mornings; with tennis requesting "weekends."

"Priority times" are not reservations for a particular sport. "Priority times" are designated times when a specific sport gets priority use of the court, with all other times being open play, first-come firstserve. These times are not monitored by staff, but are self-monitored by players, with an expectation of sportsmanlike conduct and courteous and respectful interactions. "Priority times" are not unique to Monterey. The concept is also implemented in neighboring cities such as Seaside and Pacific Grove.

At the May 18, 2017, PRC meeting the following "priority times" were established. From June through November 2017, Monday, Wednesday and Friday mornings from 9:00 a.m. to Noon were designated as "priority times" for pickleball and Tuesday, Thursday and Saturday mornings from 9:00 a.m. to Noon were designated as "priority times" for tennis.

In order to be fair to all parties, the "priority times" switched in December for an equal six-month period to accommodate tennis players. Therefore, from December 2017 through May 2018, Monday, Wednesday and Friday mornings from 9:00 a.m. to Noon were designated as "priority times" for tennis and Tuesday, Thursday and Saturday mornings from 9:00 a.m. to Noon were designated as "priority times" for pickleball. Sunday mornings and all afternoons/evenings are open times for either use.

At the May 18, 2017 PRC meeting, staff was directed to monitor the effectiveness of these "priority times" and shared use at Via Paraiso Park over the next 10 months, and re-evaluate after 12 months. There had been no change in the number of pickleball courts in Monterey. At the May 29, 2018 PRC meeting, the Parks and Recreation Commission solicited public comment regarding the effectiveness of these "priority times."

At the May 29, 2018 PRC meeting, the Parks and Recreation Commission solicited public comment regarding the effectiveness of these "priority times." At the June 21, 2018 PRC meeting, new "priority times" were set, which remain in effect today. The following "priority times" are year round and Saturdays are evenly distributed between pickleball and tennis throughout the year. Pickleball "priority times" are set for 9:00 a.m. to Noon on Monday, Wednesday, Friday and the 1st and 3rd Saturday of every month. Tennis "priority times" are set for 9:00 a.m. to Noon on Tuesday, Thursday and the 2rd and 4rd Saturday of every month. All remaining days including Sunday mornings and all afternoons/evenings are open times for either use. Staff replaced existing signage with "priority time" signage (Attachment 1).

#### **Additional Pickleball Courts**

At the September 11, 2019 PRC meeting, the PRC voted to approve adding two (2) additional pickleball courts (for a total of six courts) at Via Paraiso Park by re-striping the current courts with funding provided by the Monterey Bay Pickleball Club. As of September 2021, these two additional courts have not been added. There has been no change in the number of free public pickleball courts in Monterey and there continues to be a need for additional pickleball or mixed use courts in Monterey.

#### **Potential Dedicated Pickleball Facility**

For FY 20, NCIP approved a feasibility study to identify a suitable location for a six-court pickleball facility to include review of potential sites, engineering studies and construction cost estimates. At the time, NCIP projects to build pickleball courts could be pursued by both PRC and the Monterey Bay Pickleball Club for FY 21.

For FY 20, NCIP approved a feasibility study to identify a suitable location for a six-court pickleball facility to include review of potential sites, engineering studies and construction cost estimates. A possible suitable location was located at Ryan Ranch Park. (It should be noted that the potential location at Ryan Ranch Park will need further review and approval by other agencies such as the Monterey County Airport Land Use Commission.) For FY 21, NCIP projects were suspended due to COVID-19.

#### **Current Status**

During the pandemic and in accordance with the State's Blueprint for a Safer Economy's Tier System regulating indoor and outdoor activities, sport court play was suspended. Sport court play, including Pickleball and Tennis, was reinstated as local and State guidelines allowed. Since the onset of the pandemic, the Monterey Bay Pickleball Club has voluntarily suspended organized pickleball play and signage has been adjusted to accommodate pandemic response and some neighborhood issues such as quiet play.

The Monterey Vista Neighborhood has raised concerns about play by the Monterey Bay Pickleball Club and reported concerns about parking, noise, priority hours, and storage of equipment. The Neighborhood Association approves of pickleball on a small scale and suggests removing blended lines from one of the two tennis courts, creating one court dedicated for tennis and one court dedicated to pickleball as well as discontinuing "priority hours".

The Monterey Bay Pickleball Club is committed to growing the sport and for making it accessible on the Peninsula while working with local cities and the public at large. They also seek out partnerships with local educational institutions such as Monterey Peninsula College and Monterey Peninsula Unified School District, as well as privately run facilities such as the Chamisal and the Monterey Tennis Center, for shared access to tennis courts for pickleball use.

The City, with limited staffing resources, is dealing with the pandemic, a fiscal crisis, social equity issues and climate change. Given the fiscal and resource challenges, the City Manager has encouraged the Monterey Vista Neighborhood Association and the Monterey Bay Pickleball Club to discuss the future of a peaceful coexistence and develop a recommendation regarding the use of pickleball at Via Paraiso Park (see Attachment 3, letter from City Manager, dated March 24, 2021). At this time, the Neighborhood Association has declined to meet with the Club without a City representative present (see Attachment 4) while the Club has agreed to meet with the Neighborhood Association (see Attachment 5).

#### Subject: Pickleball at Via Paraiso Park

#### Dear Neighbors:

Over the past two years, various community groups have come together to develop workable solutions that balance the desires and wishes of both pickleball players and residents near Via Paraiso Park. We suggest that the Monterey Bay Pickleball Club and the Monterey Vista Neighborhood Association come together to discuss a path forward, and how, if any, changes should be made to the existing policies regarding pickleball play at Via Paraiso Park.

As both groups are aware, the City of Monterey's staff, Parks and Recreation Commission (PRC), and Neighborhood and Community Improvement Program (NCIP) Committee have spent considerable time since 2016 to discuss, review, and develop policies and construct amenities that support limited pickleball use at Via Paraiso Park. Subsequently, the City, with support from the PRC, striped four (4) pickleball courts on existing tennis courts at Via Paraiso Park.

The City's current regulations allow pickleball play at Via Paraiso Park on Mondays, Wednesdays, Fridays, and alternating Saturdays from 9 a.m. to Noon. These policies support pickleball use by members of the community, while providing access to tennis players and quieter times for nearby residents.

In recent weeks, the Monterey Vista Neighborhood Association has suggested changes to the current pickleball regulations, which include: singles only play, returning to first-come, first-served permits, removing one pickleball court, and other requests. We received a petition from the MVNA with signatures. Meanwhile, the Monterey Bay Pickleball Club has requested dedicated courts for pickleball play. We also received a petition from them, which also includes signatures from MV neighbors.

While a dedicated pickleball facility at Ryan Ranch Park or another facility can still be pursued through the City's NCIP, funds are very limited due to the fiscal impacts of COVID-19 (the City of Monterey is estimated to lose \$34 million due to the pandemic) and the allocation of funding and staff capacity to construct such a facility is uncertain. Our staffing resources are extremely thin, as our Recreation and Sports Center divisions experienced a 60% budget cut this year. Our current focus is to reopen our Sports Center as well as provide meaningful programming for all of our parks and yet-to-reopen recreational centers.

Given these fiscal and resource challenges, I think it is appropriate to ask neighbors to meet with each other and discuss the future of a peaceful coexistence. I am asking the Monterey Vista Neighborhood Association and the Monterey Bay Pickleball Club to meet and develop a joint recommendation regarding the use of pickleball at Via Paraiso Park.

The Neighbor Project at the Mandell Gisnet Center for Conflict Management, located at the Monterey College of Law, may be a helpful resource that provides skilled mediators to guide parties experiencing conflict. Dear Mr. Uslar, Ms. Tannahill, and Mayor Clyde,

Thank you for the update on pickle ball (hereafter PB) at Via Paraiso Park which you sent before the pandemic struck. Since the courts have been shut down or limited to two players at a time and we have all been involved in more pressing matters, we saw no urgency in responding earlier. However as things are gradually reopening, including the opening of the courts in the park, it is paramount to resume talks.

MVNA is pleased to hear that the Saturday organized club play will stop if/when play resumes. However, from MVNA's point of view, the City's overall proposal is not a win-win solution for the neighborhood. It does not address the issues cited in our initial letter to you regarding the health and welfare of our neighboring residents (or Monterey residents generally) and the protection of the neighborhood ambience of peace and quiet. Neither does it address the interests of our many local tennis players.

What the proposed plan does provide is the guaranteed long-term exclusive use of our tennis courts by an outside non-City sponsored club promoting PB organized group play by dues-paying mostly non-Monterey residents seeking to avoid better existing options outside of residential areas in Monterey and other Peninsula jurisdictions that require reasonable minimal fees outside of residential areas. Now that the budget is critically short of funds, the prospect of building a facility at Ryan Ranch is slim at best. Because PG, Monterey, Carmel, Seaside and Marina have existing facilities available for pickle ball, the expense of a new facility funded exclusively by Monterey seems unwarranted.

The policy of exclusive use of the courts by the PB club has had a dramatically negative impact on our neighborhood. Noise, parking issues, and the inability to play tennis while approximately fifty PB club players are using both courts three or four days per week, was never expected when NIP funds were used to stripe the courts for PB play. As a result, the Neighborhood Association has received many complaints. A petition voicing concerns about noise, parking, reserved times, etc., was signed by over 100 nearby residents, and provided to the City.

The City's revised policy does not address the noise issue for the many homes and residents surrounding the park. Based on our validated observations during the previous year, on the 12 days or more per month the club is now given exclusive play at the park, there will be up to sixteen players on the courts, which means four balls in play continuously for at least three hours. There will also be as many as 35 other people waiting on the sidelines for their turns to play. The combined noise of the wooden paddles striking the hard rubber balls mixed with the cacophony of participants' voices for three plus hours constitutes a real and unacceptable nuisance for the neighbors as well as those using the park for walking, picnics and the parents and children using the adjacent playground area. Understand that the park is set in a canyon and the noise carries far. Many surrounding neighbors are retired and at home during the hours dedicated to PB club play. The noise is very loud, irritating and disturbs the peace and quiet that we have enjoyed for years. Also troubling is the lack of parking during the PB club play. Few

spaces are already available in the park for residents and others who frequent the park with their children and infants who rightly want and should have easy access to utilize the facilities. On pickle ball days, for hours most if not all of the parking is used up by non-resident PB players.

As it regards the interest of resident tennis players, the revised policy dictates that the PB club will continue to have reserved play (3 weekdays every week) or twelve plus days per month, while the tennis players have allotted only (2 weekdays per week) or eight days per month. This is giving unequal use of our neighborhood park's tennis courts to the privately run PB club. It is important to note that the two courts under discussion have been exclusively tennis courts for decades, and that the 2017 NIP project to stripe the courts to accommodate PB use never included the expectation of reduced use for tennis or exclusive use times to anyone. Nor did the NIP project include a provision for the allowance of equipment storage to a privately sponsored club - a club which consists of dues paying members, the vast majority of whom do not reside in surrounding neighborhoods. The posted sign at the park indicates that organized group play is not allowed using park facilities without a permit, and presumably a paid fee. Why is an exception being made for a PB club that charges dues, consisting mainly of non Monterey residents?

We suggest the following changes be made to mitigate the various issues cited above:

- Until there is a herd immunity due to complete availability of vaccines locally, continue the
  policy of limiting play to singles only, disallowing gatherings of groups and the sharing of
  equipment. Allowing group play to happen will put our residents, seniors and young alike, at
  risk.
- Stop the preferential reserved time system and return to the first come first served basis. As a side note, the sign at VPP states that no adult team sports are allowed without a permit. Other groups pay fees to reserve the picnic area and fields. We see no reason to make an exception for organized, competitive team play by the PB club.
- Other surrounding cities provide reservable venues for PB play at a nominal cost. Because of the
  number of players, the per person charges at most facilities would be under a dollar per player
  for two hours of reserved play. The Morris Dill facility in Pacific Grove provides this option as
  does the Monterey Tennis Center. We see no reason for Monterey to subsidize more city courts
  when there are adequate alternatives already available.
- Direct or permit the repainting of one court. Removing the PB lines will return that court to
  exclusive tennis play. Non-city donations could fund this solution if City funds are unavailable.
  Having full time access to a dedicated tennis court, and the second court when not in use for PB
  play, decreases the need for residents to drive out of the neighborhood to play tennis. It also
  enhances tennis play by removing distracting lines and extends the life of the court as a
  maximum of four tennis players will be on the court versus eight PB players.
- Direct removal of the non-city storage container, PB nets and other equipment from the park premises as it presents an unnecessary liability issue for the city and taxpayers. Why is this storage being provided when the equipment is not available to non club PB players? Does this independent club provide liability insurance for all of its members?

• Other group uses of park facilities require a paid permit to reserve and access park facilities such as the picnic area and team sorts facilities. The municipal tennis courts in PG and Monterey reserve for PB play on a first come first serve basis for a reasonable fee if the club wants to be assured of courts for their group. These locations are not within residential districts and have multiple courts for tennis as well as PB. The PB club has been paying nothing for standing reservations and exclusive use of both courts in a municipal park surrounded on all sides by single family homes. Tennis players have never been allowed to reserve the courts in the park though they may at the Tennis Center and Morris Dill and the many athletic clubs with courts. It's always been first come first serve at Paraiso Park and that seems appropriate for a small multi use neighborhood park.

To reiterate, MVNA believes we haven't reached yet what we would consider an acceptable solution. While we appreciate that efforts that have been made to find venues for club PB play away from homes and residents, the fact remains that the quality of life of residents have not been addressed, nor had the inequality between tennis and PB play. We think our suggestions herein do address those issues and urge the city to adopt and implement these suggestions before allowing group use of the Courts.

To: Monterey City Manager, Parks and Recreation Commissioners (PRC), City Council Members and Parks Department

Date: March 1, 2021

The intent of this letter is to provide the City of Monterey, PRC, and City Council, with a general overview of the development of pickleball play at Via Paraiso Park (VP) and the transitions that have taken place over several years as pickleball has continued to grow locally. The ultimate goal of pickleball advocates has been and continues to be, working with community members, the PRC, etc. to establish dedicated pickleball courts.

A small group of pickleball fans first began play at VP approximately 5 years ago. Over time, as the sport began to grow locally attracting both new and more experienced players, the need for more courts became obvious to support play. As is well documented in previous PRC and NIP meetings over the past couple of years, avid pickleball players attended and presented at PRC and NIP meetings for the purpose of working together collaboratively with the community to create shared use of the tennis courts at VP, and to increase opportunities for people to use and enjoy the park. It has always been the intent of pickleball players to be respectful of the tennis player's use of the courts at VP as well as the care and maintenance of the courts themselves.

Initially, pickleball players would chalk lines on the tennis courts (since pickleball courts have a smaller dimension than tennis courts). However, this was met with a bit of resistance from a few tennis players. In order to be sensitive to tennis player requests, pickleball players would then tape courts and remove the tape at the end of play.

In 2016, following approval of the PRC and NCIP, one tennis court at VP was striped to facilitate pickleball play. This was done using a color that would not be offensive to tennis players and would blend in with the overall court color, while still being mindful of the existing tennis court lines. As the number of pickleball players continued to increase, in 2017, the NCIP approved a request by pickleball players to stripe 4 pickleball courts (in total) on the existing tennis courts. This supportive approval by the PRC allowed 16 players to play at one time, thereby vastly increasing the usage of the courts and decreasing the wait time.

All of this being said, it was agreed upon by both pickleball players and tennis players and supported by the PRC, to share the use of the courts by including all people interested in both pickleball and tennis. The initial agreement was for pickleball players to have priority on the courts on M-W-F from 9-12 noon. Conversely, tennis players would have priority use of the courts on T-Th-Sat from 9-12 noon. After six months the days would switch...pickleball on T-Th-Sat and tennis M-W-F from 9-12 noon. Afternoon play on any day was first come, first served abiding by the time limit posted on the fence signs. After 6 months, it became a bit confusing making the switch for both groups, so an agreement was made to keep the time frame as originally established for both groups while alternating Saturdays.

Again, as interest in learning and playing pickleball continued to increase, it became the focus of pickleball players to request additional support from the PRC and NCIP to establish dedicated courts for pickleball play. The NCIP granted \$4500.00 for a feasibility study to research where a suitable location for the creation of at least six pickleball courts could be built. As of this writing, there is a promising location in the Ryan Ranch area.

The pickleball community met with the Monterey city manager in February of 2020 with the purpose of finding a permanent solution to the issue of play at VP. During that meeting, which was prior to the COVID-19 pandemic, we came to an agreement that the pickleball club would give up the Saturday play at VP as gesture of good faith to the community. We had also found a viable location at Ryan Ranch that would be able to house a permanent pickleball complex. With support from the City Manager and Parks department, community pickleball players were going to submit a plan for funding through the NCIP. Unfortunately this was put on hold due to the economic downturn due to COVID-19.

Currently, there is a group of very active pickleball players who are working very diligently to make the goal of dedicated courts become a reality. This would clearly be a win-win for the community. Dedicated courts would enable more people to enjoy the health and social benefits of the game, and would continue to increase the opportunities for players of all ages and skill levels to enjoy the fastest growing sport in America.

Dear Hans,

The Monterey Vista Neighborhood Association Board discussed your mediation proposal on the pickleball issue at our regularly scheduled meeting on April 5<sup>th</sup>. The statements below sum up our collective response.

- 1. Providing an appropriate venue for a large pickleball club is a City-wide if not Peninsula-wide issue. Many of the club members live in other Peninsula cities and beyond. As one neighborhood we can not say it would be best to play in another neighborhood or town without the participation of all the other neighborhoods or towns.
- 2. We do not know what other courts in Monterey or in other Peninsula locations might be willing to serve the pickleball club though we suspect more appropriate venues do exist to accommodate a large group of club players. We have been told that the Monterey Tennis Center is opening up with four dedicated pickleball courts. The Morris Dill Courts in Pacific Grove are available for pickleball and possibly MPC is willing to have the pickleball club play there. The City also has entered into a joint facilities use agreement with MPUSD, so perhaps the City could negotiate times to make available the seldom used tennis courts at MHS or other school sites pursuant to the joint agreement and or the Civic Center Act that applies to public school facilities. Any one or more of these options or some combination of these or other venues seem like the simple answer to us until a dedicated pickleball facility may be funded and built somewhere on the Peninsula. Perhaps expense for such a facility could be shared by multiple cities that have residents seeking a location to play.
- 4. Many of our residents also enjoy large group exercise activities and for that they go to where those are available, like the tennis center or the Monterey Sports Center. We gladly pay fees to recreate in these municipal venues. Neighborhood courts in small parks are not designed for 50 people at a time with 16 club members playing simultaneously and continuously on 2 tennis courts with many club onlookers waiting for their turns to play, talking and cheering. This also involves the parking of many cars, so the availability of parking should be a consideration.
- 5. A group, who wants to meet together, needs to be prepared to pay for a facility that is designed to handle large groups with reserved times provided for them. As we understand it, dues are collected from club members. Our Via Pariaso Park is not such a location due to the peculiarly loud high pitch noise from the cumulative sounds of hard hit smashes and hits of the ball on the woolen paddles from so many playing at once. Also, neighbors and other park users cite the lack of parking and the lack of the courts for others to play tennis or non-club pickleball for extended periods of time.

- 6. Other sports groups at municipal parks pay for the use of the park facilities, like softball and baseball. Pickleball should also pay for reserved play times, but only at locations designed for that large of a group. The tennis centers all provide reserved times at an appropriate cost.
- 7. Pickleball is not seasonal, so the idea of a large group of organized players meeting in an embedded park 3 or 4 times a week for hours at a time, with no end in sight, is not acceptable to this neighborhood and we are pretty sure would not be acceptable to any residential neighborhood. This is born out by many other neighborhoods you'll discover by googling "pickleball" expressing similar complaints and petitions when pickleball is played too near to people's homes.
- 8. MVNA is not opposed to pickleball ball on a small scale in VPP. MVNA promoted the striping of the tennis courts to allow for casual first come first serve play just as it has always been for tennis before these reserved times came in specifically to accommodate large club play. Money for striping was only provided using NIP funds and this would not have occurred without MVNA's recommendation and the funds we were instrumental in securing. Club use for fifty people at a time was not what these courts are designed for. MVNA was never notified that a policy was being discussed by P&R to allow for a large scale takeover of the park and courts by a non city sponsored club on an ongoing basis. Tennis players would prefer to leave one of the two courts striped only for tennis with one court dedicated solely to tennis with no specific times provided exclusively either to tennis or pickleball. Both pickleball and tennis would be on a first come first serve basis.
- 9.. Upon looking over the pickleball petition it appears that only 12 members of the club live in the Monte Vista neighborhood. Many do not even live in Monterey. That is in comparison to the hundreds of residents that live near the park and in the Monte Vista neighborhood. Approximately 200 Monterey residents signed a petition against the allowing club play in small parks embedded in residential areas after this policy went into effect and the resultant problems experienced.
- 10. The twelve MVNA elected Board Members representing a cross section of MVNA residents voted unanimously to not participate in a mediation process by a private agency without City participation. This is a City-wide if not Peninsula wide issue. It needs to be put on the Parks and Recreation Commission agenda where our Monterey Vista Neighborhood Association members and residents can voice their concerns, along with the Pickleball Club. Better and more appropriate choices are available in Monterey and other Peninsula Cities nearby in which many club members reside. It should be a community wide interest to explore what options exist to serve the needs of pickleball clubs in a way that does not create a nuisance to residents. MVNA wants to be part of the conversation, but it should not be our conversation with the Pickleball Club alone. Please let us know when it will be on the agenda so we can participate in crafting a solution.

Dear Mr. City Manager, Parks Department and Neighbors of Monterey:

I'm writing regarding the City Manager's letter (via email) of March 24, 2021, requesting the Monterey Bay Pickleball Club (MBPC) and the Monte Vista Neighborhood Association (MVNA) develop joint recommendations regarding pickleball at Via Paraiso Park and suggesting the use of mediation to discuss "peaceful coexistence". The MBPC Board and I have been working to develop our points-of-discussion and to put together a mediation team to represent the pickleball community, including Monterey residents.

As you know, since the March 24 letter, the City of Monterey relaxed COVID-19 restrictions on the use of public park facilities, including doubles play at the tennis and pickleball courts at Via Paraiso Park (VP). Since March 2020, out of concerns for the health and safety of the pickleball community and the VP neighborhood, the MBPC has maintained a strict policy of not supporting play on these courts. I am aware of pickleball play occurring at these courts in the last month (and singles play earlier), but that is not supported by MBPC, nor has the MBPC Board modified its COVID-19-related guidance to club members.

MBPC had conversations with MVNA early in 2020, before the pandemic, which were frankly not very fruitful. We think mediation with the Mandell Gisnet Center could be a constructive next step. In the last few days, however, I've learned that MVNA representatives at the April 14 Parks and Recreation Commission (PRC) made public statements of their intent to <u>not</u> participate in mediation. I did not receive this communication directly from MVNA, so I could be mistaken.

I would encourage the MVNA to reconsider mediation. In these times of multiple crises, I personally believe communication and fair play is fundamental to the repair and rebuilding of our communities. To make the best use of our shared public parks and other limited resources, we should work together.

I also saw Mr. O'Leary's letter to the Editor of the Monterey Herald, published April 27. Mr. O'Leary continues to make the erroneous claim that the VP courts are reserved for "club pickleball play". As I stated earlier, MPBC is not and has not been actively supporting pickleball play at these courts for over a year. Furthermore, the City's current regulations provide "priority", not exclusive, play for both tennis and pickleball on these courts on different mornings. Priority play is for people, not clubs. MBPC has no agreements with the City for exclusive use of these courts.

As you know, just before the pandemic, I suggested that the priority play structure could be rebalanced by having priority mornings M-W-F from 9am-12pm for pickleball and T-Th-Sat from 9am-12pm for tennis. It was previously M-W F 9am-12pm for pickleball and T-Th 9am-12pm alternating every other Saturday. This was from an agreement and recommendation from the tennis players at keeping this schedule permanently rather than rotating every 6 months.

MBPC would like to clear up our misunderstandings with the MVNA. When we start mediation, we can all air our grievances and peacefully exchange our points-of-view.

I also propose the PRC Chair or designated commissioner participate in the mediation. This might have multiple advantages:

- these individuals can provide a more neutral point-of-view regarding the history of pickleball at VP and current regulations
- these individuals will be implementing any agreements and, by participating, will have a clearer understanding of the intent
- active participation by such third parties should encourage both MBPC and MVNA to take the mediation more seriously and, hopefully, improve the chances of a successful outcome
